As well as rumen buffer to reduce the risk of acidosis, ammonium chloride is included to reduce the risk of urinary calculi (water belly) as well as ionophore to improve live weight gain and feed conversion

The balanced starch, sugar and fat content provide a safe feed with a reduced risk of acidosis.

Improved Utilisation

The inclusion of cooked cereal grains contribute higher levels of gelatinised starch, together with the steam conditioning of Proteena® Pellets in the production process, further gelatinises the starch content, thereby improving digestion and feed efficiency.

Feeding guide

Proteena® Sheep Utility 12/14 Pellets are designed to feed up to 40% (max) of your flock's or cattle herd's dry matter intake in pasture based system.

For Lambs: (Recommended daily intake up to 40% of total Dry Matter Intake (DMI))

Dry Matter Intake (DMI) of 20 - 50kg lambs (3.5% of body weight) = 700g - 1.75kg DMI/day

700g - 1.750kg x 40% = 280g - 700g on a Dry Matter (DM) basis

As fed (As Is): 300g - 750g/day

For Cattle: (Recommended daily intake up to 40% of total Dry Matter Intake (DMI))

Dry Matter Intake (DMI) of 500kg steer

(3.5% of body weight) = 17.5kg DMI/day

17.50kg x 40% = 7kg on a Dry Matter (DM) basis

As fed (As Is): 7.8kg /day

We also recommend access to good quality pasture and fresh water at all times.
